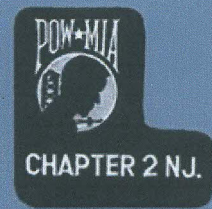

SCHOLARSHIP PROGRAM

2011 – 2012 School Year

To Whom It May Concern:

Rolling Thunder ® Inc., New Jersey Chapter 2, will be awarding three (3) \$1,000 scholarships for post-high school education (college, community college, trade school, etc.).

The Scholarship Committee has established the following criteria for eligibility:

1. Applicant must be a child of a military member, veteran, or a fallen soldier. Proof of parent military service required.
2. Applicant must be a resident of and be a graduating high school senior in Monmouth, Ocean, Burlington, Atlantic, or Camden County, New Jersey.
3. Applicant must write an essay on *“How being a military child has been a positive influence on their life.”*
4. Applicant must submit verification of acceptance at a particular school with application.
5. Essay must be typed. Application may be hand printed legibly.
6. Applicant may submit only one application per school year.
7. Applicant must sign and date completed application. Parent or Guardian signature is also required for applicant under the age of 18. Signature of school Guidance Counselor is required.
9. Rolling Thunder® will distribute \$500 for each semester. The scholarship recipient must mail a copy of the second semester class schedule as proof of enrollment to Rolling Thunder at the address provided above.

Application, essay, letter of acceptance and proof of parent military service must be mailed to Rolling Thunder®, Inc. New Jersey Chapter 2 at the above address. Application package must be received no later than April 20, 2012. Applications received after the deadline will NOT be accepted.

The Scholarship Committee will select the three (3) winners of these scholarships from all eligible applications. The winners will be notified prior to the awards being presented.
