Mr. Pellegrino asked Mrs. Coates to report on the stop work order relating to the elementary school window replacement project due to asbestos found in the caulk. She explained that the wing was built at the same time and should have had the same caulk in the windows however there was an overlay of two other types of caulk resulting in three different types of caulks present in the window wing. She reported that after working with the professionals for a week the first change order price came in at \$39,800 and was revised downward to \$31,800 then to \$21,100 with the final price being \$20,110. She reported that Environmental Connection, our current environmental consultant, will be onsite during the removal providing air sampling at a cost of \$10,910. She asked the board for their direction in moving forward and approval to place this on the next agenda. Dr. Kasyan, in speaking with the Mr. Garrison, feels that this is a great and justified price. Mrs. Coates said that all other windows have been pre-tested in the high school that are going into the bid phase in addition to the second phase of elementary school windows and there was no evidence of asbestos. Mrs. Coates pointed out that there is \$10,000 of allowance on this project and this can be put towards this expense, in addition to a \$9,300 change order credit on the project. The board was in agreement with placing the change order on the next agenda and moving forward with the project.

Mr. Pellegrino asked for a motion to approve Manasquan/Sending District Item #9 – H.S. Personnel – Document 1.
