

#### "COAST STAR" STORY INACCURATE



"The teachers were totally unaware of the Wednesday article in the Asbury Park Press," exclaimed Manasquan Education Association secretary Miss Diane Radtke. "We were confronted with parents at Open House who had more information than we did." Contrary to popular belief, the MEA did not drop the vote of "no confidence" concerning the administrators. which they voted for last May. According to MEA president Mr. Walter Campbell, the association chose to drop the specific complaints on legal advice by Martin T. McCue, the MEA's lawyer.

The letter "mis"-explaining the teachers' message was read by Board president Robert Solt at the October 18 Board of Education meeting. As a result of the letter, Mr. Solt recommended a vote of confidence from the Board to the administration. The general feeling on the Board though, was that the term "vote of confidence" was too strong a phrase. Board member Timothy Capewell suggested that "a general statement of support" might be an improvement.

The Board finally voted for a vote of confidence after a half-hour discussion.

#### Kidd Was a Reality

The life history of Captain William Kidd has been unravelled beyond encyclopedia knowledge and Kidd's 20 year disappearance was discovered by the investigator, Mr. Robert Schlaefer.

Captain William Kidd was born in 1645 in Grennock, Scotland, but no records were saved to varify this.

When he was 16 years old he signed on to the navy fleet, the Fleetship. During his adventure, he spent many years in the Far East with his friend, Mr. William Dampier.

After his service in the navy, Kidd appeared in New York City in command of all the trade from New York to South Carolina and to the West Indies where he conducted business for years.

The English authorities found out Kidd and his crew were spending Arabian coins and wanted to know where they came from. He fled to Madagascar, the headquarters of all the pirates in the world. (Before a ship can go towards Madgascar, a white pirate flag must be sailed or else it will be shot at.)

When he returned to New York, he had a new crew. Kidd appeared in front of the authorities and was then ordered to go see the King of England. He was commanded to seize and take any pirate on any seas. A 46 gunner ship was given to him with the King's flag flying and a crew consisting of criminals who didn't fill up the number of men needed.

After leaving England he sailed straight to New York and recruited friends on his ship. With a full crew aboard, he headed for Madagascar where he stayed there for three days. He then travelled to the Far East and India to achieve his goal-capture a treasure ship.

Dampier, Kidd's old friend was also involved in the treasure ship goal. Dampier was located in India with the Mogul, the king, who thinks Dampier is good friends with him. The Mogul's daughter was to be married and sailed away on a ship with jewels, gold and money. Around this ship were 46 other ships protecting it. Instead of keeping these original plans, Dampier knowing Kidd's plans explained to Mogul that it would be too obvious to keep the ship in the middle. Instead, it was located on the outside so Kidd could easily detect it. When Kidd approached, he went directly to the treasure ship, captured it, tied it to his ship with masks and took off. Within minutes, the 46 ships were chasing him. This happened during the menses season and Kidd escaped the 100 feet waves.

Kidd disappeared for 20 years where only a few people know his whereabouts including Mr. Schlaefer. At this time, Schlaefer will not reveal his knowledge.

He began travelling to the West Indies after 20 years under an assumed name. Everyone was after him. He was a wanted man. Kidd stayed at the post master general's house in Boston. Eventually, the British officers caught up with him and brought Kidd to New York in chains where he stayed until the next ship to London. In the end he was hanged for piracy, a wrong charge, in 1701.

Mr. Schlafer comments, "There may not have been a Captain Kidd. It wasn't his real name. If anyone is interested in Captain Kidd, he should contact Mr. Schlaefer who resides on 607 9th Avenue in Belmar.

### Pagano's Batik Hits 5th Avenue

"I design pillows using batik for a company named Sunshine Pony, that deals with such stores as Sach's of Fifth Avenue, Sloans, Bloomingdales, and Bonwitt Teller," stated Mrs. Karen Pagano, Manasquan High School's art teacher.

Mrs. Pagano explained, "Batik is basically an ancient Indonesian art originally used for the clothing of royalty and for ceremonial garments. In the past 15 years, there has been a revival in the crafts such as macrame, weaving and batik. Traditional batik, which I use, is a wax resistant process where the fabric is dyed. Afterwards it is waxed to prevent the next dye from penetrating the already dyed area. Contemporary batik is done in many ways, such as magic markers, melting crayons and painting with colored wax."


The art teacher said it all started when she answered an ad in a newspaper. "I showed slides of my art work. They (Sunshine Pony) liked them but wanted to see less detailed samples that could be reproduced quickly and be more appealing to the general public. They enjoyed my new samples and hired me."

There is a great difference between regular art work and commercial art work Mrs. Pagano stressed.

"If a store is interested in having a pillow made to match a specific sheet, they tell Sunshine Pony who in turn asks me. I then design and batik a pillow to match the sheet. The sample pillow is given to the store and if they approve, an order is placed. The pillow is then reproduced by other members of the company and each is individually batiked. My name is signed to it and there is hardly any difference between my original and their copy," remarked the Interlaken resident.


When asked about her future plans, she stated, "I would like to continue teaching as well as designing. Right now the Sunshine Pony is small and I see a great potential for expansion. Eventually the company wants to buy a converter which would mechanically reproduce my designs for sheets, pillow cases, bedspreads, etc."

Mrs. Pagano's work has been in major stores on Fifth Avenue. For Christmas, Sachs and Sloams will be featuring her pillows for the holidays.

When Ed Asner played Lou Grant in the "Mary Tyler Moore Show", he did his apprenticeship. The WJM television station of which Lou was producer wanted all new personnel so he went looking for a new job. Lou found a place as a city editor for a major daily paper. Unlike the "Mary Tyler Moore Show", "Lou Grant" is not a comedy but is termed a "drama with comedy overtones". Also, while the "MTM" show featureed a small station, "Lou Grant" is set in a huge news room that comes closer to looking like an actual news room than any other show I've seen. The show deals with more serious types of news stories and pits Lou against the managing editor (Mason Adams) and the rich publisher (Nancy Marchand) in continuous battles about where to put stories " and whether or not to publish them. these cases most of the controversy is over the way two young reporters played by Robert Walden and Claudette Nevins write their stories. Walden,

right out of the Carl Burnstein mold, is a bad guy character who writes libelous things while Nevins is a more likeable character who battles to have her stories on the front page. Lou

In most episodes Lou spends his time squabbling over who should cover what. Last week's drama had Lou arguing with the feature editor on who should cover the murder of a famous playwright. As usual in the end the publisher steps in and Lou doesn't get his way. Earlier in the season Lou was given his first test as an editor when young reporter Robert Walden tests his new editor by claiming that a veteran of the police force is sitting on evidence of a departmental scandal. The hot shot reporter hands in a story to Lou making a lot of accusations without basis. Lou asks him to write the story over and not make charges without proof. In a great acting job Ed Asner asserts who's boss and who is the reporter.

A topic that comes up with newspapers these days was also dealt with. A man wielding a gun takes over the news room and asks that a story be retracted because it was damaging to him. The paper is forced to print the story and the terrorist is captured. Again in this episode, Nancy Marchand makes the decision on the story, not Lou, and does a great portrayal of the publishing tycoon.

Realistic is the word for "Lou Grant". It is by far the best portrayal of an actual news room situation yet. Ed Asner has always been a good a serious actor as a comedic actor. Except for the Robert Walden character which is very hard to like, the co-stars in the drama are adequate. The only other problem I see with the show is that being the city editor, Lou might try to become a detective. This is a fine show and it might take some viewers from "Family".

4.) Getting out early is good, but going to school early is bad. It's useful for jobs and other activities but my big grudge is a test first thing in the morning.



No search or arrest can be made unless there is probable cause to determine a law is being broken. All citizens are protected from search unless they are handed a warrant signed by a judge.

Arrest is the only element of crime that is stressed on TV but most of these "Super Cops" wouldn't get a conviction because they get the evidence by coercion or when the person is under duress. Many TV detectives threaten people into confessing or letting them search.

This week's article concerns pollution, its causes and effects on the society.

There are many types of water pollution in our environment. The main types affecting us are sewage, oil spills, effluents, and man-made.


Sewage deals with the garbage and raw sewage dumped into the streams and oceans. As many of you know, swimming was not permitted in New York and parts of New Jersey for most of the summer. This was due to the raw sewage dumped into the water day after day in New York. Some of this drifted into New Jersey waters. The pollution killed off much of the marine life and increased the algae bloom causing the red tides many of us saw. Garbage also was dumped from boats, which drifted to the beaches. Who wants to swim in Garbage?

Oil spills also are a major cause of water pollution. Modern technology

did not get involved with this problem until the giant tanker, the Torrey Canyon, broke off the south coast of England in 1967, releasing 31 million gallons of oil into the water. The British relied heavily on the use of dispersants for the clean-up. Dispersants are chemical compounds that act to stop the spreading of oil and to sink it to the bottom of the ocean. This killed much of the marine life, and today, France and England are poor in fishing. The best way to remove oil is the use of hay spread out over the oil. Hay is a natural absorber.

This Athlete of the Week is a natural with a big future ahead of him. Gary Bridges is only a sophomore but he has already played for two varsity teams.



This Spring Lake Heights' resident was a top basketball and softball player in grammar school. During high school though, she has concentrated solely on tennis.









## Squan Harriers Have Tough Week


Manasquan runners had two trimeets in one week, dropping three of the four teams played and moving their record to 6-6.

What started as communication amongst coast-to-coast truckers, is now a bona fide American pastime. The airwaves originally used for relaying road and weather reports, are now the airwaves that bring thousands of Americans together in a common passion. And why not? CB radio is fun and a great way to make new friends.

What's most appealing to many people is the special CB language, a colorful zesty jargon developed by the truckers themselves, borrowing freely from pop songs, D.J. patter and plain old teen-age street talk.
